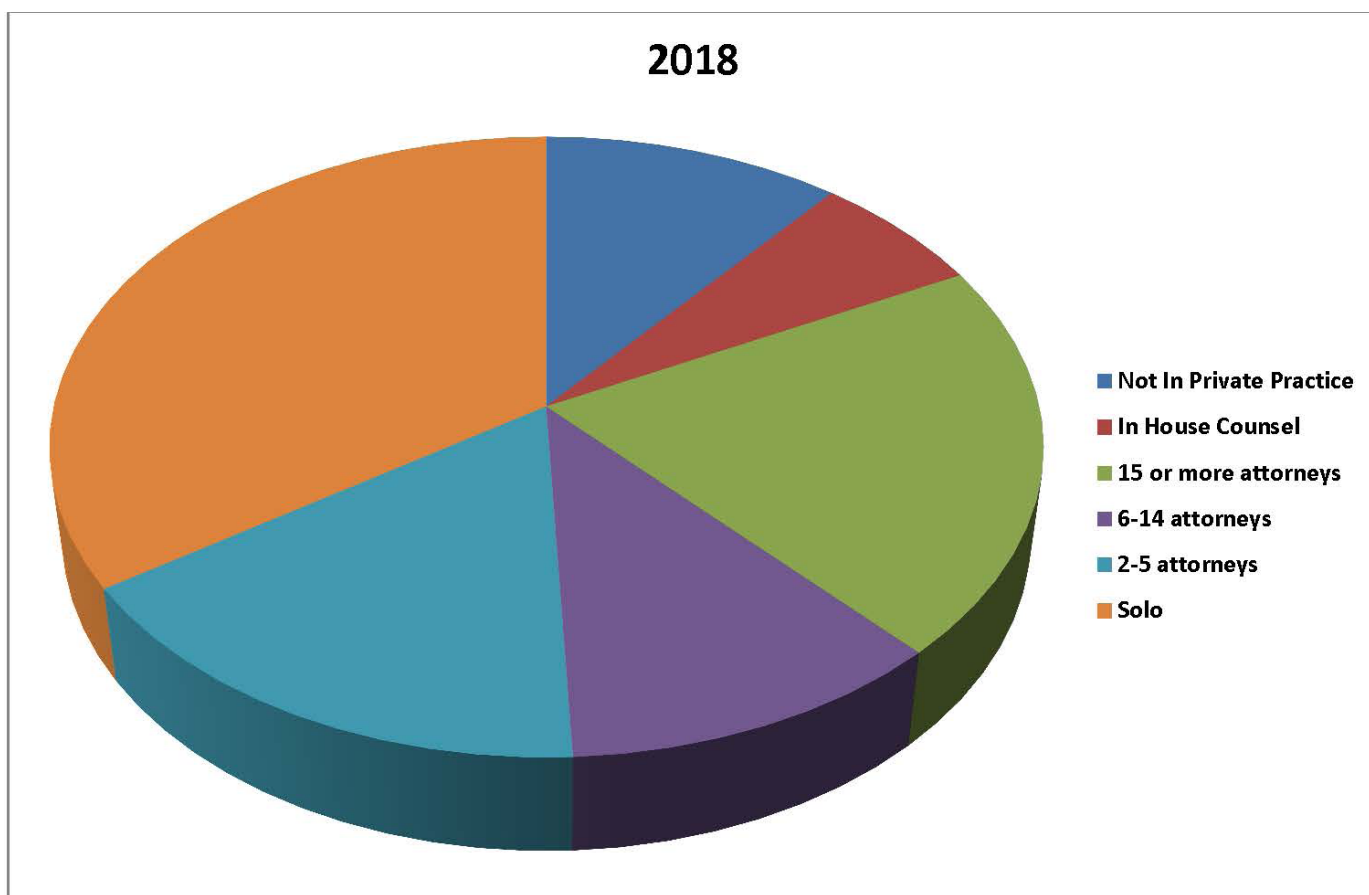

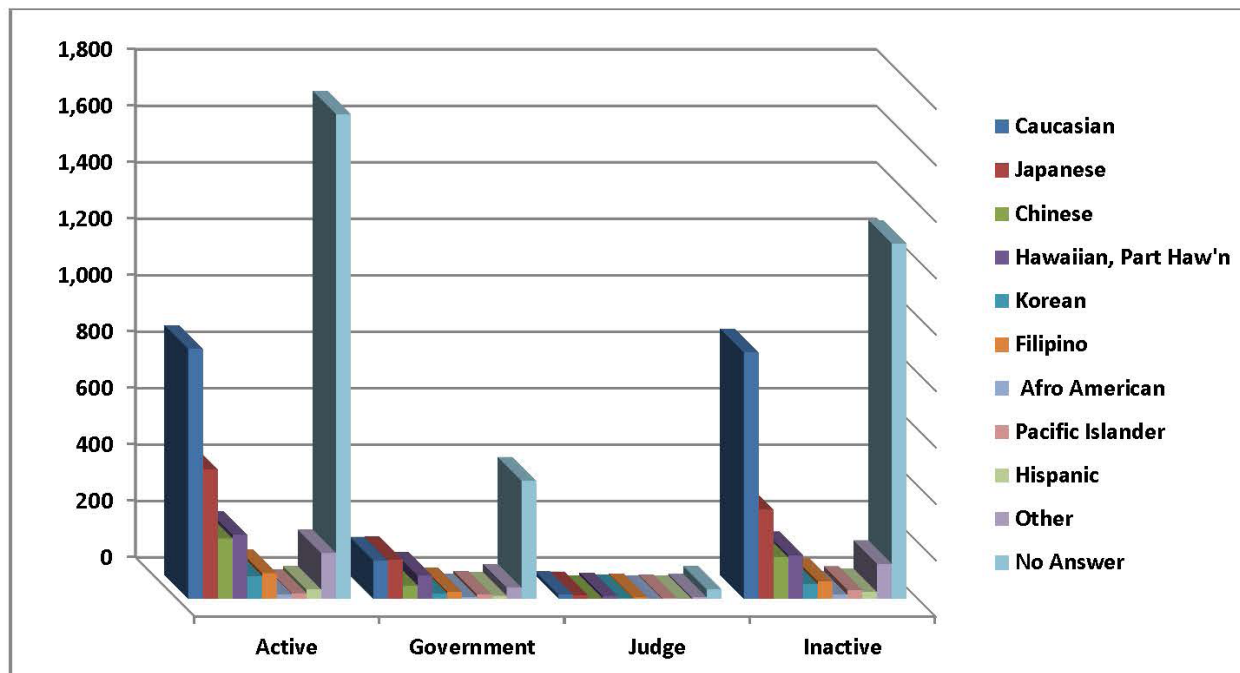

2018 MEMBERSHIP STRUCTURE



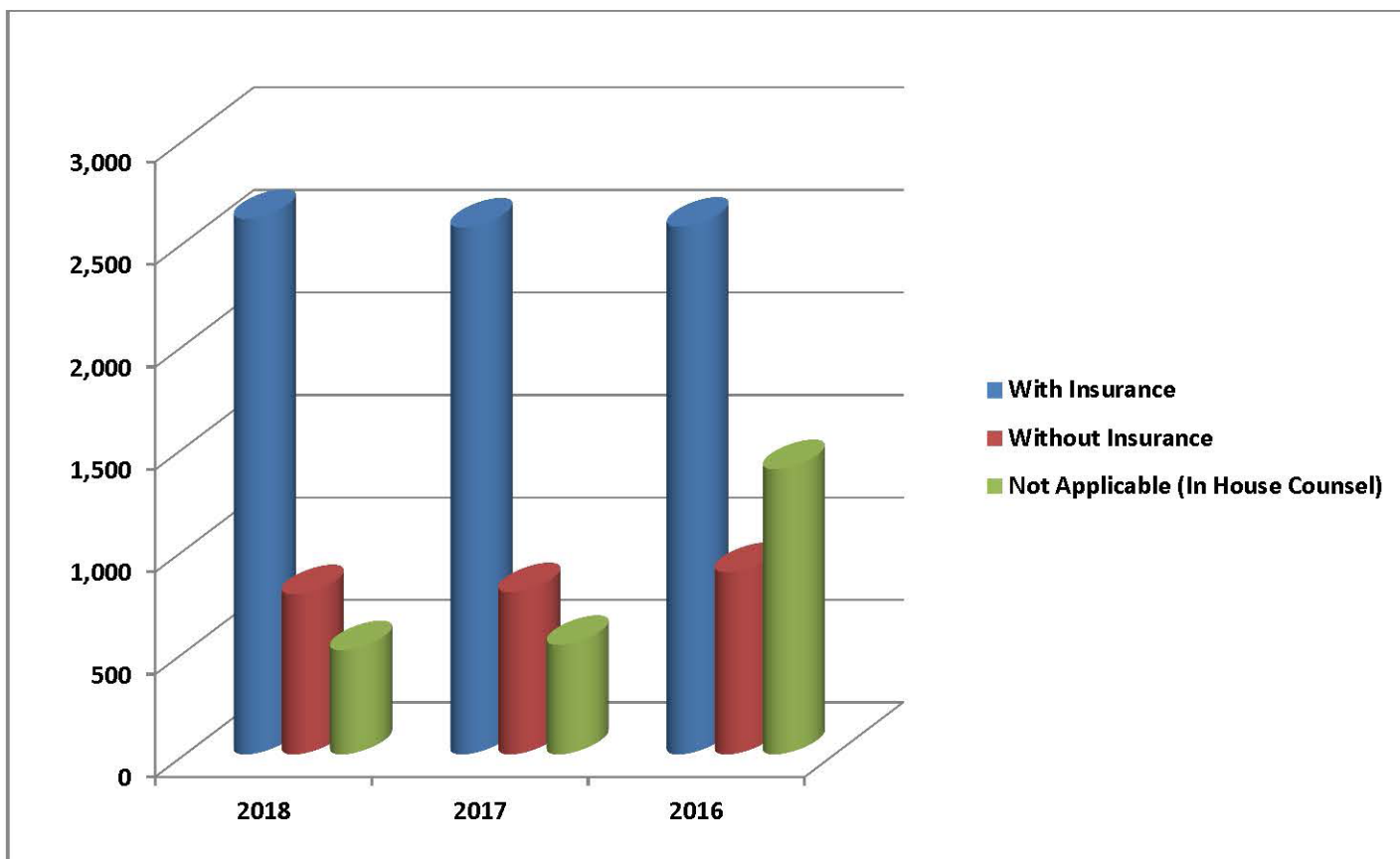

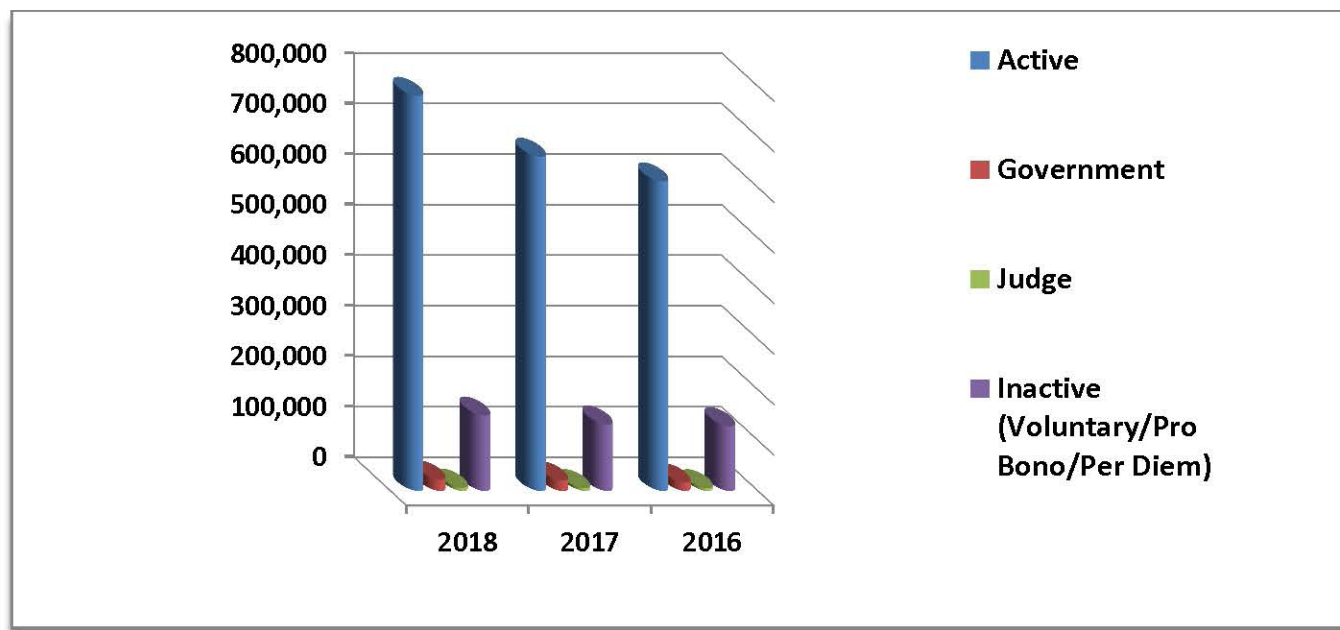

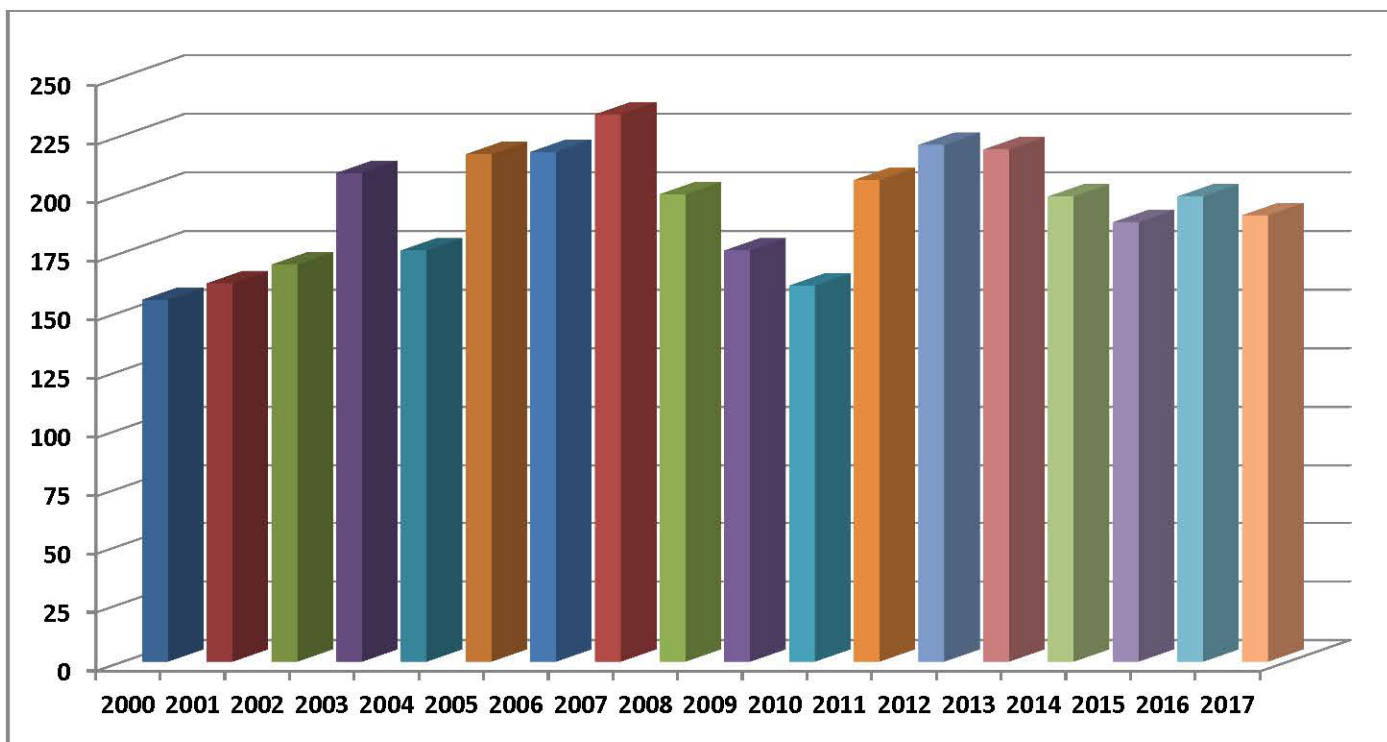
